

RAG TAG MISFITS - TERMS AND CONDITIONS

General

Please read carefully our terms and conditions document, which will apply to every booking taken by the band, these terms and conditions apply to the client. Our contract agreements are designed to offer protection to both the entertainer and the client.

Fees

Rag Tag Misfits require private clients to pay a deposit when booking entertainment for Weddings, private functions etc. This deposit is normally 20% of the overall fee (unless travelling abroad). Travelling expenses will usually be included in the price quoted. Unless stated otherwise. This deposit is non-refundable (Rag Tag Misfits will only refund a deposit payment when the engagement has been cancelled by us in extreme circumstances, in this case, the full deposit will be refunded immediately). Deposits must be received by us before we can issue any confirmation.

Final Balance – The final balance fee for any private engagement must be received by us before or on the date of any engagement. Final Balance fees are usually paid in cash or card on the night, however other payment terms may be available on request. The final balance amount is made clear in each contract.

Cancellation

In the extremely unlikely event of the band cancelling the agreement due to injury etc. Rag Tag Misfits will endeavour to offer you an alternative entertainer of similar size, style and cost. If this is unacceptable, Rag Tag Misfits will offer you a full refund. As a hirer you can request to cancel a contract agreement, however the following charges will apply.

If you cancel

0-60 Days from engagement 100% of the agreed fee
61-90 Days from engagement 75% of the agreed fee
91-120 Days from engagement 60% of the agreed fee
121-180 Days from engagement 50% of the agreed fee
181 + Days (Deposit Fee Only)

The above cancellation fees are an important part of our agreement and are accepted by the client on receipt of our contract. All cancellation fees must be paid within 10 days of cancelling the engagement.

Performance Times

The performance time of the band is specified in each contract. Please note that contracted start times are based on the band having access to the performance area preferably at least approximately 1 hour before the contracted start time. Please note that the band are not responsible for hotel overruns and are not obliged to play beyond the contracted finish time. If on the night you require a band to play additional sets this can be negotiated on the evening if the band has no other prior engagements.

Rider Requirements

Depending on the timings and location of the performance please find our rider requirements. We are able to negotiate requirements if necessary. Technical requirements can be forwarded to the relevant sound engineer if requested.

Access – Parking – close to loading area and for the duration of our stay.

Performance space – Reserved ready for setup. Full PA requires electric point. If available minimum 4m x 4m performance space for full PA. Pop up acoustic and wandering performance (no electricity required). If available minimum 3m x 3m performance space for pop up acoustic. If an outside performance is required suitable cover should be provided in the event of bad weather to protect both the performers and equipment.

Catering – Soft/hot drinks, water and a meal (if early setup is required). No dietary requirements.

Accommodation/Green Room – If available and unless agreed otherwise. Overnight accommodation is required if performance is more than 100miles from home address with evening performances in the UK. For performances outside the UK accommodation is required for the duration of stay. 1 Double Room with Breakfast.

Contracts & Agreements

Every Rag Tag Misfits verbal agreement is formalised with a written contract/booking confirmation. This protects both you the client and us the entertainers. On receipt of our contract, the document should be signed and emailed or posted back to us by return.

Business and Corporate Clients

Our business and corporate clients are also subject to our terms and conditions. The only exceptions are. Business or corporate clients may not have to pay a deposit fee to secure the band. Cancellation agreements still apply for Business and Corporate Clients.

Business or corporate clients may not have to pay their final balance before the engagement takes place or on the night. In the event of us agreeing any arrangements with a client we will subsequently invoice them after the engagement takes place. The client must settle our invoice strictly within 28 Days or additional charges may be incurred.
